MEETING OF THE GIUNTA DI FACOLTÀ
5 MARCH 2020

On Thursday 5 March the Dean of the faculty called for an urgent meeting of the Giunta di Facoltà.

On Thursday 5 March 2020, from 4 pm to 5 pm, the Giunta di Facoltà has met electronically.

The meeting opened at 4.00 pm by sending the draft minutes via e-mail with the proposed resolution and with the invitation to the members to express favorable or contrary determination on the following item on the agenda:

1. Emergency COVID-19: teaching, exams, degree sessions.

1. Emergency COVID-19: teaching, exams, degree sessions.

In view of the actual health emergency, the government's provisions and the suspension of teaching activities decided by the University, considering that the University has decided that the profit exams and the degree exams "*can be taken respecting the precautionary rules to avoid contagion, as indicated by the Dpcm dated 04.03.2020, ensuring that the examination is taken in a public form*", in the material impossibility of respecting for all the exams such "*precautionary rules*" provided for the protection of students and teachers, the



Giunta di Facoltà orders the suspension of the profit exams until next March 15. The exams will be rescheduled as soon as possible on successive dates.

On the other hand, in order not to cause any serious harm to the students who are about to graduate, the already scheduled graduation exams are confirmed, but in absolute respect of the aforementioned "precautionary rules". Therefore, the graduations will be held in large rooms, so that the distances between people can be respected; moreover, each candidate will be allowed to be accompanied by no more than two people.

With regard to classes, in accordance with the University's directives, it has been proposed to make available to the teachers the computer equipment and the necessary technical support of specialized personnel, in order to provide the possibility for each person to carry out, during the days of suspension of the frontal teaching, any class by telematics.

The University will send the guide lines to provide useful information to use IT tools.

The distance teaching activity will be accountable as frontal lessons.

In any case, it is proposed to delay the end of the lessons from 9 May to 16 May

The student representatives fully approve the content of the minutes and they fully agree with the analysis and the *ratio* of the proposed decision on the suspension of the exams and the need to ensure that the graduation exams are carried out in absolute respect of the aforementioned "precautionary rules".

The student representatives also request that the suspended exams will take place at the end of the emergency and they reserve the right to request a possible extraordinary modification of the exam dates foreseen by the current teaching schedule.

The proposed resolution was adopted unanimously.

There is nothing else to discuss, the meeting closes at 4.41 p.m. of 5 March 2020.
